Membership Categories

Resident Membership “Family Membership”

- Any person who is at least twenty-one years
- A resident member shall have full privileges for himself or herself and all children in his or her family who reside in the same household and who are under the age of thirty.

Social Membership

- Any person at least twenty-one years of age may join the Club as a Social Member.
- They shall have full use of the Clubhouse for dining, events, and other social functions.
- They may use the athletic facilities with the exception of the pool twice a month with appropriate guest fees.

Junior Membership

- Any person under the age of thirty-five may join the Club as a Junior Member.
- Once the member has attained the age of 35, he or she will be required to pay the difference (i.e., the difference between what the regular initiation fee was for full members at the time they joined and what they actually paid).
- The annual dues structure for this class will not be reduced.

Legacy

- This class has been established to recognize the children of long-term members (10 years or more) in good standing
- Children must be at least 21 years of age, but not older than 34 years of age.
- Legacy members will not be required to pay any additional initiation fee upon attaining the age of 35.
- The annual dues structure for this class will not be reduced.



Non-resident Membership

- A person may not join as a non-resident member.
 - After a person has been a resident member for a period of at least one year, then the person may apply to change membership to non-resident, assuming all the criteria for this class are met.
- Any persons at least twenty-one years of age who reside within a city or town, any border of which is not closer than at least sixty miles from any border of the Town of North Andover.
- Restrictions on use of facilities are as follows:
 - Non-resident members have unlimited use of the Clubhouse for dining and social purposes.
 - They may only use the athletic facilities of the Club for not more than 2 days a month and pay appropriate guest fees.
- Non-residents may not be the guests of other members of the Club.

Senior Membership

- Any person who has been a member of the Club for at least twenty-five years may apply to become a senior member upon attaining the age of 75.
- The annual dues shall be reduced by one-fourth of the dues which the member had been paying immediately prior to becoming a senior member.

Life Membership

- Qualified candidates for Life Membership are those members 85 years of age and above, with the most continuous years of membership, but in no case less than 35 years.
- Upon written request to the Board of Governors, Life Memberships shall be granted to qualified members in good standing.
- Members passing to Life Membership shall retain all the rights and privileges from their most recent membership class, and shall be exempt from dues, assessments, and minimum charges.

Notes

1. Age classification is dependent on the age of the older spouse as of the beginning of the Club's fiscal year, October 1.



2. Whenever the member is for two persons, such persons shall be a married couple (husband and wife). A married person may not join the club as a single member. A single member who marries must convert his or her membership to a full membership.
3. It will not be possible to provide memberships of less than a full year's duration. Thus, for example, members who live in the area for only a portion of the year will not be able to acquire a full membership for the summer or any other season.
4. Requests for changes in classes which result in reduction in fees will be considered upon notification of such request in writing.
5. Memberships in good standing who wish to relinquish their memberships temporarily may apply to the Board of Governors for one-year leave of absence after which they may either rejoin with no additional initiation fee or resign. Those members who resign from the Club and then wish to return at some later date may apply for the membership by paying an initiation fee that is one-half of the difference between what the fee was when they resigned and what it is when they reapply. However, in any case, such member shall pay no less than the amount of any assessments imposed on the membership since their resignation.
